Medical information

Diagnosis:

(based on x-rays, MRI, patient history/anamnesis)

You are a professional table tennis player since 2005 with a body height of 193 cm and now indicating typical groin pain.

Surgery plan:

There is an indication for hip arthroscopy with bone resection of the head-neck area, cartilage and labral repair and partial synovectomy of the left hip joint. Surgery should be done on both sides at different times, starting with the most painful hip.




AP Pelvis; 23.10.2015

There are clear signs of femoroacetabular impingement on both hips with an LCEA of 38° (left) and 41° (right), obvious labral ossifications and early osteoarthritis.
